Minutes: The meeting began at 11:45 a.m. and the December 2022 minutes were reviewed.

<u>Motion</u>: A motion to accept the November minutes was made by Steve Hood; Dan Solazzo seconded the motion. All in favor, motion approved.

Clermont Sports Financials:

- Balance in account went from \$732.75 to \$48,737.97 with December contribution from CVB and payment of bus turn around paving/curb for regattas.
- Expenses were \$16,400 for East Fork park improvement for regattas, Internet, ACA event graphic design and accounting fees expense.

<u>Motion</u>: Steve Hood made a motion to approve December's Clermont Sports financial report as presented. Nick Baker seconded the motion. All in favor.

CVB Financials:

- Balance sheet: Checking account has a \$159,643.94 balance. \$66,400 was contributed to Clermont Sports for capital expenses and 2023 USRowing regatta.
- P & L: Lodging tax came in at \$97k from October and finished with \$747k in 2022.
- Larger expenses included memberships to industry organizations, professional fees for sales consultant and accounting firm, technology software and meeting registrations.

Investments: TD and Edward Jones were both slightly down for December.

<u>Motion</u>: Steve Hood made a motion to approve December's CVB financial report as presented. Nick Baker seconded the motion. All in favor.

President's Report:

- STR report: November and December were slightly down for occupancy. January should be improved and trending upward again.
- Clermont Sports Update:
 - USRowing contract for 2023 being finalized and should have in February.
 - Clermont Sports will buy a trailer for hauling start dock, so the dock does not get damaged in transport.
 - o First LOC meeting being planned for late February for regattas.

Sales Update:

- New Sales Manager Patrick Korosec started January 17th.
- Posted Marketing & Sales Coordinator position to LinkedIn and Indeed.
- North American Chinese Basketball Association (NACB) booked for May 26 29, 2023.
- Following up w/additional sports organizations, meetings and group tour.
- Patrick and Jeff will attend Heartland Travel Showcase being held in Cincinnati for group tour market.

Marketing Update:

- Sarah and Jeff are working on content for new visitor guide with Great Lakes Publishing. Will have new guide end of March.
- CVB is working on 2023 marketing plans, print ads for March publications.
