<u>P&L</u>= Income section, we see the check we received from US Rowing in the amount of \$66,415. Expenses associated with the event for the month is \$49,691.61. This event brought in \$96,415 and cost \$115,076.59. The economic impact of the regatta was approximately \$2.5 million.

<u>P&L-</u> Memberships for the month came in at \$2,454.
