Clermont Sports Development Corp:

<u>Balance Sheet</u>: On the Balance Sheet, Cash went from \$156,401.45 to \$46,196.52. This is a net decrease of \$110,204.93. This decrease is directly related to the net loss on the P&L of \$204.93 and repayment of amount due to CVB.

P&L: Expense – Internet paid for 2 months. Going to move to monthly auto payment.

### **Clermont County CVB:**

Balance Sheet: Total cash went from \$386,796.28 up to \$552,035.91. This is an increase of \$165,239.63. This is directly related to the net income for the month of \$55,239.63 and the repayment of \$110,000.00 wiped out the balance on the Due From Clermont Sports line and lowered Due From Clermont Sports Exp Reimb to \$35,246.71. Revenue and Expense: The CVB received lodging tax in the amount of \$109,265.64. This amount represented room nights for August along with the unpaid amounts from July room nights that did not get into September income. Marketing & Promo expense of \$14,218.63 for ads, listings, sponsorships and printing. Professional fees for Brixey & Meyer and Paychex.

Edward Jones decreased slightly, and Charles Schwab decreased slightly over the previous month. Still discussing having both rolled into one account but need to have board member's review. Tressa able to get the Money Market value through 3/31/25.

STR: October 2024 occupancy +6.3% and YTD is -.9%, ADR-1.4% and YTD -.8%, RevPar +4.9 and YTD -1.6%, Supply +6.4% and YTD +.4%, Demand +13.1% and YTD -.4%. Home2 by Hilton opened on 10/22. Inventory and room renovations complete at Fairfield, but now Holiday Inn Eastgate has rooms out of circulation due to

renovations. We had warmer weather and more leisure visitors for fall festivals and Halloween events. Corporate and Business travel saw slight uptick before Election and Holidays.
