# Treasurer's Report: Dan Solazzo Clermont Sports Development Corp:

Balance Sheet: On the Balance Sheet, Cash went from \$2,826.98 to \$156,401.45 This is a net increase of \$153,574.47 due to payment from NCAA.

<u>P&L:</u> Income of \$8,623.40 from Apparel Sales and \$156,693.59 from Event Income. Apparel Sales was used to lower the Due to Clermont County CVB line and deposited into the CVB bank account.

## **Clermont County CVB:**

<u>Balance Sheet:</u> Total cash went from \$400,274.19 down to \$386,796.28. This is a decrease of \$13,477.9 and is directly related to our net income on the P&L.

<u>Revenue and Expense:</u> We received lodging tax in the amount of \$97,303.34. This amount represented room nights for June.

Expenses for marketing included Google ads, Key Word Search, sponsorships for Film Cincinnati and Elite Athletics and Nothin But Net. Expenses for Consulting Services, Ohio Conference on Travel and TEAMS meeting registration.

Edward Jones increased slightly, and Charles Schwab increased slightly over the previous month. Still discussing having both rolled into one account but need to have board members review.

### President's Report: Jeff Blom

**STR**: September occupancy -6.1% and YTD is -1.7%, ADR-4.3% and YTD -0.6%, RevPar -10.1 and YTD -2.3%, Demand -6.1% and YTD -2.0%. Factors contributing to this include inflation, the hurricane/rain weekend, travel is down in the Midwest overall and the Reds poor finish to season.

**CSDC Update** – The NCAA rowing championships selected Sarasota for 2027/28. Since USRowing broke their 2025 contract, we are looking to obtain a buy out in addition to possibly hosting a sprint beach race in 2026. ACA (American Canoe Association) will be hosted here in July/August 2026. Scholastic Rowing looking into Memorial Day weekend for an event, but not sure if East Fork willing to be closed for part of the holiday weekend.
